Fee Structure

FUNDRAISING BOND

Fundraising is essential for the financial viability of the Toy Library. Membership fees only cover running costs and minimal toy purchases with the majority of toys purchased from grants and fundraising initiatives. A bond of \$30 is payable with your membership and is refunded to you once you have fulfilled the fundraising obligations in a membership year (or may be rolled over for another year of membership). If you do not fulfill your fundraising obligations in the membership year, your fundraising bond will be retained by the toy library and the bond will be payable again with your next membership renewal. All Toy Library policies, including the fundraising bond, are fully detailed in the Members' Information Booklet.

Toys may be borrowed for a maximum of two weeks and will incur a penalty fee of \$1 per toy per week for every week they are overdue. If, due to special circumstances you are unable to return your toys when they are due, you should contact the Community House during office hours on 9803 2335 within 48 hours of your due date. Fines and charges apply for missing and damaged pieces (including toys, bags and boxes) as outlined in the Members' Information Booklet.

You agree that if you fail to return a toy within a reasonable time, or in any event, within 2 months of its return date, you will reimburse the Toy Library for the cost of replacing the toy.

The rules for borrowing and using the toys are set out in the Members' Information Booklet. By signing this application form you agree to be bound by those rules and the regulations set out in the Members' Information Booklet.
